

The Allen's Major Award

High Point Lippitt Versatile Show Horse Competition

This competition is the brainchild of Anne Ashby of Auburn, New York. She and Gerry have most generously donated a trophy, in the memory of their great stallion Allen's Major. It is the hope of the Ashby's that this competition will inspire more Lippitt owners to get out and show, so that judges will be reminded that there are still old-type Morgans in the world. As Anne wrote "If we can get a lot more old-type Morgans in the show ring, they will not be overlooked, and it might help to reverse this trend for "New Type Morgans."

Eligibility: - Owner must be a member of The Lippitt Club, and horses must qualify as Lippitt or first generation half-Lippitt, according to the Lippitt Country Show guidelines. To include points in any class for five shows, to stress versatility by making it mandatory that at least three of the categories below are included (not necessarily at any single show.)

The competition will run through the calendar year (January 1st to December 31st.) The deadline for submitting forms for the prior year show season shall be February 1st of the current year. The forms should be sent to the Lippitt Club Secretary.
